The 26th Management Committee of the Singapore Wushu Dragon & Lion Dance Federation was dissolved on 28 July 2020 after its final Meeting. With the dissolution, the Election process for the 27th Management Committee has been activated together with the formation of an Election Committee.

The Election Committee has decided that Nomination commences with immediate effect. Nomination will close at 5.00pm on 12 August 2020. Thereafter, the Election Committee will examine all the nomination forms received.

The Election Committee will inform all Ordinary/Associate Members by 20 August 2020 the list of qualified candidates, details of the voting process and 2020 Annual General Meeting (AGM). Thank you.
