NOTICE is hereby given that the Extra-ordinary General Meeting (EGM) of the Singapore Wushu Dragon & Lion Dance Federation (SWDLDF) will be held on Monday, 31 March 2025 at 11.00am in the Training Hall at its Bedok Office at No 7 Bedok North St 2 Singapore 469646.

The Agenda of the EGM is to discuss and approve the proposed Revised Constitution of the SWDLDF as required by the Sports Singapore, the governing authority of National Sports Associations (NSAs), for all NSAs. Ordinary and Associate members can authorise 2 representatives to attend the Extraordinary General Meeting. Every representative can only represent one organisation. The Extraordinary General Meeting Proxy Form (Refer to Annex) must state the representatives' full name. The President, Chairman or Secretary General must sign and stamp the organisation seal on the form to be considered valid. Incomplete submission would not be accepted.

Representatives from the Ordinary and Associate members must bring their NRIC to proof their identity and they must be of a minimum age of 21 years old. The attire for the Annual General Meeting is smart casual. Shorts and slippers are not allowed.

The Management Committee has waived the Membership Fees for the Financial Year (FY) from 2020 to 2023. It has resumed collection of Membership Fees from FY 2024 onwards. Only representatives from Ordinary and Associate members who have paid their Membership Fee can attend the Extraordinary General Meeting.
