Date of Publication: 14 March 2025

1. Introduction

The 33rd SEA Games will be held in Thailand from 9 to 20 December 2025.

2. Objectives

- a) To nominate the best athletes to the Singapore National Olympic Council (SNOC) for participation in the 33rd South-East Asian Games (SG25) in Thailand. The aim of these successfully nominated athletes will be to achieve the best possible results for Singapore. The final selection for SG25 will be at the discretion of the SNOC.
- b) This policy may be amended at any time if deemed necessary by SWDLDF or SNOC. SWDLDF will not be responsible or liable for any consequences resulting from such amendments.
- c) SWDLDF will publish this policy on SWDLDF website at (www.wuzong.com). Athletes and coaches will be responsible for ensuring that they are fully aware and understand the policy and its content, as well as any changes made to the policy should they occur.

3. Selection Committee

a) The selection committee shall consist of:

	TAOLU
A)	SWDLDF Vice-Chairman (Wushu)
B)	SWDLDF Secretary General;
C)	Chairman of Wushu Sub-Committee;
D)	Head Coach for Taolu;
E)	Technical Experts (3 pax – IWUF International Wushu Taolu Judges)
F)	Secretariat (High Performance Manager/Executive)

- b) The Selection Committee will consist of 8 pax.
- c) Technical Experts on the Selection Committee for Taolu will be randomly chosen from willing volunteers who hold the IWUF International Judges qualification for Taolu.
- d) The Selection Committee will be responsible for organizing and monitoring the selection procedures.
- e) The Selection Committee will review the final list of athletes to be nominated to the SNOC based on the selection criteria and team structure requirements.
- f) The Selection Committee members will sign a Declaration of Impartiality and Confidentiality (Annex A). This is to ensure that all Selection Committee members execute their responsibilities in an honest, transparent and accountable manner.
- g) The Selection Committee is authorized under this policy to use their professional discretion in selecting athletes for SG25, provided they can demonstrate that their decisions were made with integrity, using reasonable and justifiable information and procedures.
- h) In the event that no athletes have met the selection criteria, the SWDLDF reserves the right to make the final decision on the nomination of any athletes to the SNOC. Nominations of athletes who have not met the selection criteria will be accompanied by justifiable reasons for the athletes' nomination.
- SNOC is the sport governing body in Singapore responsible for selecting athletes for the SEA Games and reviewing any appeal cases submitted by National Sports Associations (NSAs). SNOC holds the authority to make the final decision regarding which athletes will participate in SG25.

4. Selection Process

To select the athletes that the SWDLDF will nominate to represent Singapore in Wushu Taolu in SG25, SWDLDF will apply the selection process:

A) Selection Trials for SG25 Nomination

A.1 Eligibility for Selection Trials for SG25 Nomination

To be eligible to participate in the Selection Trials for SG25 Nomination, athletes

- a) Current member of SWDLDF's Wushu Taolu National Training Programme
- b) Must be a Singapore citizen and should not be holding dual citizenship if they are above 22 years old.
- c) Must be eligible to represent Singapore in the international sports competitions.
- d) May or may not have been previously nominated for other international competitions by the SWDLDF.
- e) Must possess the knowledge and ability to execute difficulty movements, as required by the rules and regulations set by the International Wushu Federation (IWUF).
- f) Must have achieved a score equivalent to or more than the 3rd place scoring in the 2023 SEA Games in a recognised competition OR must have achieved at least a 3rd placing amongst South-East Asian Countries in a recognised Asian or World level competition if they wish to take part in Taolu events. Please refer to **Annex B** for the list of 3rd place scores by event for Taolu in the 2023 SEA games, and refer to **Annex C** for the list of recognised competitions. Please note that results from competitions listed in Annex C, if achieved before 1 October 2024, will not be considered for athlete nominations to SNOC should the athlete be selected. This is in accordance with the SNOC 33rd SEA Games Selection Criteria outlined in

Annex D. Instead, these results will only be used to determine <u>eligibility</u> for participation in the SG25 selection trials. Please take note that meeting this criterion only qualifies an athlete to participate in the selection trials for SG25 nomination.

g) Must show interest in representing Singapore in SG25.

A.2 Criteria for Selection Trials for SG25 Nomination

a) During the selection trials, athletes are required to demonstrate at least one routine selected from the table below.

I. Level of Commitment and Attendance (40 points)

- a. Based on their rate of attendance over the last 3 months.
- b. Depending on the athlete's attendance rate, he or she will be allocated points as seen in the table below:

II. Attitude (10 points)

- a. Based on their attitude during training in the last 3 months, the head coach will evaluate the athletes' attitude.
- b. Depending on the athlete's grade, he or she will be allocated points as seen in the table below:

III. Performance and Style (30 points)

a. Based on their execution of the selected Taolu event, the athletes will be ranked based on their performance and style.

b. Depending on the athlete's ranking, he or she will be allocated points as seen in the table below:

IV. Technical Competencies (20 points)

- a. Every two weeks, Taolu athletes training under SWDLDF will undergo a test to track their technical competency called Athlete Competency Tracking (ACT). ACT results for the last 3 months will be considered to judge Technical Competencies.
- b. KPI is recorded as a total score of 30 marks. To obtain the score for Technical Competencies, the KPI result will be converted to a score out of 20. This KPI result will be the athletes average KPI result for 3 months prior to the selection trial.
- **A.3** After the Selection Trials for SG25 Nomination, based on the results of the trial, and the team structure requirements, nominations will then be made to SNOC to represent Singapore in SG25.
- **A.4** In the event that two or more athletes who have selected the same event achieve the same score during the Selection Trials for SG25 Nomination, SWDLDF reserves the right to replace one of them with another athlete (who may or may not be of a lower ranking) who has chosen a different event, for nomination to SNOC.
- **A.5** All athletes who participate in the Selection Trials for SG25 Nomination will be informed of the results in writing.
- **A.6** In the event that after selection, the athlete is not able to participate in an international competition and unable to demonstrate the ability to achieve a Top 3 ranking amongst South-East Asian countries between date of publication of this document and 15 July 2025, SWDLDF reserves the right to replace the athlete and nominate the next ranked athlete from the selection trials that has participated in an international competition and achieved results that demonstrates the ability to achieve a Top 3 ranking amongst South-East Asian countries from date of publication of this document to 15 July 2025. Please note that results achieved between 1 October 2024 and the publication date of this document **cannot serve as the primary basis for athlete nominations** for SG25; they may only be used to support nominations.

A.7 Athletes are prohibited from discussing personal or performance-related grievances regarding selection matters with the press/media or on social media. If athletes feel they have been treated unfairly, they should utilize the appropriate channels for appeal.

A.8 All athletes are responsible for keeping confidential any information shared by the SWDLDF, particularly regarding public or media announcements about their participation in competitions or games, unless prior consent is obtained from the SWDLDF or SNOC.

5. Code of Conduct for Athletes Selected for Representation of Singapore at SG25

- a) Upon selection, athletes are to
 - Conduct oneself in a manner that upholds the principles of fair play and responsible behaviour.
 - ii. Acknowledge, respect, and comply with the authority of the SWDLDF.
 - iii. Avoid using any substances that may hinder performance, including, but not limited to, tobacco and alcohol.
 - iv. Refrain from using any substances prohibited by the World Anti-Doping Code, as enforced by the World Anti-Doping Agency (WADA) and Anti-Doping Singapore (ADS).
 - v. Maintain or enhance fitness levels to ensure that competitive performance meets the high standards required for both local and international competitions.
 - vi. Attend all training camps as required.
 - vii. Complete sports science tests as required.
 - viii. Comply with the policies and rules set forth by the SWDLDF and SNOC's team membership agreement.
 - ix. Meets the attendance requirement of 90% and other stipulations outlined in the SWDLDF Athletes' Handbook.

- a. In the case of absence or injury, the athlete is to produce a valid medical certificate from a qualified physician for submission to SWDLDF.
- b. The athlete shall direct any requests for release or absence from training to the SWDLDF.
- c. Athletes who are unable to attend training sessions must notify the SWDLDF in advance.
- x. Show respect to all individuals, including coaches, competitors, officials, and spectators.
- xi. Honor and respect the property of others.
- xii. Refrain from illegal or inappropriate behaviour that could harm his/her reputation and that of the SWDLDF and Singapore.
- xiii. Maintain a positive attitude and behave in a manner that brings honour to him/herself, the staff, the sport of Wushu, the SWDLDF, and Singapore.
- xiv. Remember that he/she is an ambassador for both the SWDLDF and Singapore.
- b) SWDLDF will not tolerate any behaviour that reflects poorly and is presented as a negative example of Singapore, SWDLDF or Wushu as a sport. Failure to comply with the above may lead to a reassessment of eligibility to remain on the team or immediate expulsion from the team.
- c) If an athlete has disciplinary issues or displays behaviour that could harm the image of Team Singapore and the SWDLDF, the athlete will be referred to the Selection Committee. Based on the ruling by the Selection Committee, the athlete may be held responsible for the total costs incurred as a result of their successful nomination for SG25 (including travel, hospitality, and entry fees). Additional disciplinary actions may be taken depending on the severity of the incident(s).

6. Appeal Process

- a) Appeal against non-selection must be made in the form of writing, with valid and clear reasons for appeal, and be addressed to the Chairman of the SWDLDF within 24 hours after the selection results are released. Written intentions to appeal must be sent to the email: info@wuzong.com.
- b) The only ground for appeal is that the selection process was not properly followed. No other reasons for appeal will be entertained.
- c) An appeals panel will investigate any appeals raised against the selection process. The appeals panel will consist of 5 individuals that did not take part in the selection committee.

- d) A fee of \$327.00 (inclusive of GST), payable to Singapore Wushu Dragon & Lion Dance Federation, must be made for any appeal. If the appeals panel finds the appeal to be unreasonable or without merit, the deposit will be forfeited.
- e) The appeal process will not involve a re-selection but will focus on evaluating whether the original decision was made correctly. If any issues are found in the selection process, athletes will not need to undergo a re-trial. Instead, the original selection committee will be directed to make the necessary corrections. The appeal committee will then review these corrections before finalizing and announcing any changes to the selection outcome.
- f) SWDLDF will, in writing, inform all parties of the Appeal Panel's decision to either uphold or reject the appeal. The decision of the Appeal Panel will be final and no further correspondence will be entertained.

7. Disputes

a) In the event of a conflict or dispute, SWDLDF reserves the right to interpret this document and exercise its sole discretion in resolving the matter.

- I agree to make decisions based solely on the established selection criteria and the information presented, without favouritism or prejudice towards any athlete or party.

2. Confidentiality

- I understand that all information, discussions, and documents related to the selection process are strictly confidential.
- I agree not to disclose or discuss any confidential information regarding the selection process, decisions, or outcomes, except as required within the scope of my official duties on the Selection Committee.
- I will not share any details of athletes' performance evaluations, scoring, or personal data with any unauthorized individuals or external parties.
- This commitment to confidentiality remains in effect during and after the selection process, unless otherwise authorized by SWDLDF.

By signing this declaration, I affirm my understanding of and commitment to these principles. I acknowledge that any breach of impartiality or confidentiality may result in my removal from the Selection Committee and potential further action by SWDLDF.

- 1. 10th Asian Wushu Championships 2024^*
- 2. The World Games Series 2024 Hong Kong^
- 3. IWUF 3rd Taolu World Cup 2024 ^
- 4. 1st China-ASEAN Wushu Championships 2024
- 5. Singapore National Wushu Championships 2024

*Please take note that results achieved in these competitions <u>will not</u> be used in athlete nomination should the athlete be selected at the SG25 selection trials. This is because this the timing of these competitions does not fall within the results consideration timeframe stipulated in the SNOC 33rd SEA Games Selection Criteria (Annex D).

Please note that results achieved between 1 October 2024 and the publication date of this document cannot serve as the primary basis for athlete nominations for SG25; they may only be used to support nominations.

If athletes wish to submit scores from competitions not listed, they must request approval by contacting the Wushu Subcommittee Chairman at wushuchairman@wuzong.com. The request should include details such as the date and location of the competition, along with the regulations and finalized results. A written response will be provided via email once a decision has been made.

Annex D

Selection Criteria 33rd Southeast Asian (SEA) Games 9 to 20 December 2025



Correct as at 23 September 2024

1. Nomination Criteria

- NSAs seeking to nominate athletes for the Games should establish qualifying standards and criteria, at least 13 months before the Games. These are open to all athletes and they should satisfy these standards in the NSA sanctioned championships. NSAs are required to submit their NSA Selection Criteria to SNOC/SSI for endorsement before publication.
- NSAs should state clearly in the nominations via SportSync at least 6 months before the Games, the justification for the athletes to be selected.
- Athletes must be <u>Singapore Citizens</u>, and should not be holding dual citizenship if they are above 22 years old, at the time of nomination.

2. Selection Criteria

Subject to the other considerations listed at paragraph 3 below, the following criteria shall be applied in the selection process:

- Athletes who have currently achieved at least <u>3rd placing</u> e.g., time/distance/score/mark of the 2023 SEA Games. For team sports, they should currently be ranked 3rd among the SEA Games countries.
- Athletes/Teams who miss the qualifying standard marginally but show potential to equal or surpass it in time for the Games.
- All achievements submitted for consideration should have taken place at international competitions sanctioned by the International and/or Regional controlling bodies, but NSAs may submit the achievements from overseas championships and meets of athletes studying in overseas tertiary institutions. However, these have to be properly accredited and sanctioned to be accepted.

- All achievements should be achieved from 1 October 2024 up to 5 September 2025, which is 2 weeks before the 19 September Entry by Name deadline, as the nominations have to be submitted to the SNOC Appeals Committee for approval before the deadline.
- Pursuant to the Olympic Charter (By laws to Rules 27 and 28, paragraph 2.1), "Selection shall be based not only on the sports performance of an athlete, but also on his ability to serve as an example to the sporting youth of his country."

3. Other Considerations

In addition to the above selection criteria, the following "qualities" of the athletes will be taken into consideration:

- Attitude and behaviour towards coaches, teammates, fellow athletes, officials and sports administrators, whether in relation to sporting matters or otherwise.
- General conduct and character which may affect the reputation, image, values or best interests of the athlete or the sport.
- Past disciplinary record;
- Current skill level and fitness: and character
- Level of commitment and attendance.
- Potential for future development:
- Ability to demonstrate team spirit and work well with teammates and officials; and
- Such other non-performance related qualities as the selectors may consider to be relevant.

4. Extenuating Circumstances

In consideration of the performance and "qualities" of athletes, the selectors may at their discretion give consideration to extenuating circumstances. For this purpose, "extenuating circumstances" mean an inability of the athlete to compete in and/or attend event, training camps or other required attendances arising from:

- Injury or illness.
- Equipment failure.
- Travel delays.
- Bereavement; and
- Such other circumstances as the selectors may consider to be relevant.

5. Selection and Appeals

- The SNOC Selection Committee will meet in July 2025 (subject to the Organising Committee's confirmation of the Accreditation deadline) to discuss the nominations from NSAs and select athletes/teams for the Games.
- NSAs can submit appeals to the SNOC Appeals Committee for athletes/teams who
 are not selected at the Selection Committee. In the appeals, NSAs have to provide
 new information that meets the selection criteria, information which had not been
 previously submitted to the Selection Committee.
